## From the President

Dear Colleagues,

Welcome back! I hope that each of you had a wonderful break and enjoyed special time with friends and family. Time away from our everyday tasks can be remarkably restorative.

The start of a new year provides an ideal time to reflect on where we have been and where we are heading. As we celebrate the first few months of 2020, we must recognize the heroic work that lies ahead for each of us in our respective roles, and in the communities we serve. We can also look forward to the future with excitement.

I know when I began my role as a superintendent seven years ago, I thought I knew all there was to know about the role of a superintendent. Very early during my first levy election season, I learned that all was not as I had thought. There were hidden systems of communication and expectations. I found navigating these systems to be difficult when I relied on my own stubborn methodology or insight. I realized what was needed was to be strategic, transparent, and relentless on outcomes. These experiences led to success and improved student learning. Trust was not given up front but rather earned through the experiences, the seemingly innocuous moments, and with much humility and friendship. I am extremely pleased to be able to say that we have passed all levy propositions in years past.

Last month many participated in the Washington State School Board Directors' Association Annual Conference in Bellevue. It was a wonderful opportunity to learn from each other. Most districts were represented and included student representatives, new and experienced board members, and superintendents. During the shared weekend, we engaged in powerful conversations about the future of

teaching and learning as it relates to public education policy and advocacy.

A collective of the three “ships”—relationships, leadership, and partnerships—were evident in the conversations and offerings at the conference. In addition, WASA's core tenants of Leadership, Trust, and Advocacy were clearly visible. It is our overriding priority to represent all students in public education in the state, as we are positioned to make a difference at every local level and statewide initiative. To achieve this aim, we must anticipate the many legislative issues that will define this session and occupy our legislative colleagues. As we reach out this month, we must not remain silent on the impact of past legislative actions and its effect on our children in the schools they represent. You are the resident expert in pre-K–12 education in your community.

We encourage administrators to use the 2020 Session to educate legislators about school district staffing needs and build momentum for further action in the 2021 Session.

The recommendations from the OSPI Staffing Enrichment Workgroup inform our partners in the Legislature of what is needed to eliminate the opportunity gaps. The report concluded that high supports and expectations for all students are delivered by a workforce that is diverse, culturally responsive, racially literate, and aware.

In addition, the report states that Washington's K–12 students must be served by equity-based policies that support and empower educators, families, and communities.

As reported, the workgroup's recommendations are as follows:

1. Modify current prototypical school level sizes.
2. Meet students' needs for safety as well as mental, social, emotional, and behavioral health.

3. Provide impactful professional development to all staff.
4. Increase flexibility with transparency and accountability.
5. Raise staffing levels to meet those set in Initiative 1351 and provide additional funds for schools in the Capital Budget.
6. Reconvene the Workgroup. The report provides a student-focused, phase-in approach over six years to address the gaps.

As you participate in both local and statewide efforts for the improvement of schools and student learning, we must collaborate and incorporate hope and positivity into our messaging.

In this last respect, WASA has [comprehensive resources](#), so please take full advantage of the unique opportunity your membership provides.

In sum, 2020 starts with great promise of even greater accomplishments for our education community. Granted, we will always face barriers, problematic issues, and symbolic leaches and mosquitos in our respective positions. It is our ability to translate these into opportunities for action and long term change that allows us to lead as transformative leaders.

And so, as we start a new year, may we contemplate and think about what might be...

*Life ends when you stop dreaming, hope ends when you stop believing, and love ends when you stop caring. So, dream, hope and love—Make Life Beautiful.*

Thank you for all that you do to make WASA and your communities a thriving place for children and staff.

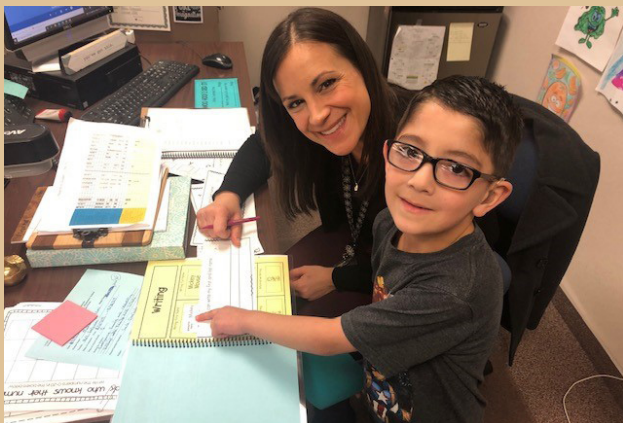

## Who's Telling Your Story?

### Personalized Learning in West Valley SD

The American Institute of Research with the cooperation of the American Association of School Administrators (AASA) is researching the implementation of Personalized Learning in West Valley School District for a case study. A member of the AASA Personalized Learning Cohort, West Valley was chosen to tell its story of Personalized Learning implementation. Currently at the mid-point of what they believe is a very successful implementation, West Valley is working to establish student-centered learning environments in all classrooms. "Tailoring learning to meet the individual needs of the learner" is the definition that is sought through this process.



Above is a photo of Cottonwood Elementary kindergarten teacher Abigail Ferguson presenting a badge to one of her students for his Badge Book. The Badge Book is an outstanding example of standards based grading: clearly identifying the kindergarten standards, putting them in a booklet, and making stamps/badges that students are presented upon demonstrating mastery of the standard. Students are motivated to demonstrate mastery and earn badges to put in their badge book.
